- 1. Call to order by P. Sheppard at 2:08 pm.
- 2. Unanimous approval of November 12, 2013 meeting minutes.
- 3. Announcements
 - A. The list of November degree candidates was presented.
 - B. P. Sheppard announced a special Graduate Council meeting for January 13, 2014 to discuss the Task Force on Graduate Education Governance recommendations.
 - C. M. Farmer-Kaiser announced that the approved changes to registered thesis/dissertation hours would be done as a University-wide catalog change, as approved by the Academic deans.

4. Old Business:

- A. Clarification was made regarding the official policy for Graduate Faculty on official sick leave. Rather than count time away from the University on sick leave as part of a Graduate Faculty member's term, the Graduate Council proposed that an "option to request extension of their appointment equivalent to the time of their official University sick-leave," be added to the current Graduate Faculty sick leave policy. Motion made to add proposed verbiage to sick leave policy. Motion seconded and passed. The Graduate Council also clarified the Graduate Faculty policy for Graduate Faculty members who are part of a thesis/dissertation committee and then lose Graduate Faculty Status. Motion made to clarify policy with the following wording: "Any current chair or committee member who no longer holds the appropriate status during the time he or she serves on that committee will be allowed to continue to chair or serve on the committee for two years after having lost Graduate Faculty status." Motion seconded and passed.
- B. M. Farmer-Kaiser requested that the Graduate Faculty application submission process be revised to allow only electronic submissions. Motion made to accept submission policy revision. Motion seconded and passed.
